## Probation officers claim gender bias in complaint against the city

The union representing more than 800 probation officers has filed a complaint against the city, alleging pay discrimination against women and people of color who make up a majority of union members.

The United Probation Officers Association filed the complaint with the Equal Employment Opportunity Commission on June 7, alleging that when white men made up the majority of probation officers, "the salary ranges appropriately reflected the value of the job." Today, nine in 10 probation officers are people of color and 68 percent are women, the complaint states.

"It is time for the City to show it is committed to supporting the dedicated professionals who work in Probation," said UPOA

# Probation officers claim gender bias in complaint against the city

President Dalvanie Powell. “For too long our members have been underpaid and undervalued. We are bringing this claim to put an end to that. The city can either be part of the problem, or part of the solution.”

In September, the UPOA sued the city to demand detailed salary information for city employees in other comparable agencies. In December, the UPOA again sued the city, this time alleging that the city blocks probation officers from attaining promotions and earning wages commensurate with supervisory roles.

Powell told the *Eagle* in April that officers serve a crucial function in the city’s justice system, by working with people convicted of crimes who are not sentenced to jail or prison time.

“Probation officers are an alternative to incarceration,” Powell said. “We save the city and state hundreds of thousands of dollars by keeping people out of the prison system.”

The role of probation officers has expanded since the city and state implemented Raise the Age reforms that move the majority of cases against people under age 17 out of Criminal Court and into Family Court in October 2018. Probation officers handle intake procedures for children arrested in New York City, while supervision probation officers work with young people who are convicted of a crime but not sentenced to jail.

The New York City Department of Probation told the *Eagle* it has “not received notification of an EEOC filing and remains committed to the fair and equitable treatment of every employee.”

The Kurland Group law firm is representing the union.

### MOM CHARGED IN DEATH OF SON RETURNS TO COURT

Phyllis Reinoso is charged with first-degree assault and manslaughter related to the death of her son with epilepsy. Reinoso appears in K6 for a conference.

The Jamaica mom allegedly neglected to administer two types of vital medication to her 5-year-old son, who suffered from uncontrollable focal seizures that resulted in hospitalization and ultimately death, according to the district attorney’s office.

When Reinoso’s son Michael Guzman, was diagnosed with focal epilepsy in October 2012, doctors repeatedly instructed Reinoso to administer two daily doses of medication to combat the boy’s disorder, prosecutors said. A doctor also allegedly warned Reinoso that failure to administer the medicine on a consistent basis could result in the boy experiencing frequent seizures and even death.

### SHOOTER’S COUSIN INTIMIDATED WITNESSES, PROSECUTORS SAY

Samuel Ceruti is charged with second-degree conspiracy for allegedly intimidating a witness who testified in his cousin’s murder trial. Ceruti appears in TAP C for a conference.

Ceruti’s cousin Tyrone Ceruti allegedly shot and killed a construction worker in Astoria in 2015. Prosecutors say Samuel Ceruti threatened to shoot a witness testifying against his cousin.

“Prospective witnesses must be protected from outside interference that might affect their testimony,” said late Queens DA Richard

Brown. “This office will not tolerate the intimidation of, or tampering with, witnesses and is committed to the vigorous prosecution of those who engage in such conduct.”

# What to know about the diversity recommendations de Blasio just embraced

## A 'big deal' or not enough?

Mayor Bill de Blasio endorsed a series of recommendations offered by the city's School Diversity Advisory Group, an announcement that top city officials — and even some integration advocates — heralded as a triumph.

"Today's a big deal," Chancellor Richard Carranza said, noting the city had accepted virtually all of the advisory group's 67 recommendations. It "represents the systemic change that we've been yearning for," said Mark Treyger, chairperson of the City Council's Education Committee.

But despite the soaring rhetoric, the suggestions the city has pledged to adopt don't come with precise integration goals, changes to any enrollment policies or a timeline for seeing results.

The initial recommendations made by the advisory group, released in February, did not address some of the most explosive issues — including gifted and talented programs or academic screening — that advocates say are essential in addressing segregation. The Education Department's latest announcement sidesteps those issues, too.

Instead, the city has pledged to push schools to be more representative of their surrounding districts and boroughs — with the goal for schools to eventually match citywide demographics. That is a more aggressive target than the city's previous diversity goals, which experts said were extraordinarily modest. Officials also announced Monday that five additional districts would receive \$200,000 each in grant funding to begin the process of crafting hyper-local integration plans.

Some school integration advocates who were part of the diversity advisory group said those efforts represent an important milestone.

"This is more policy that's been implemented than anywhere in the country I've seen voluntarily," said Matt Gonzales, who supports school integration work through the nonprofit New York Appleseed. "This is a critical step."

Monday's announcement, which de Blasio previewed in an op-ed, is

notable partly because the mayor has been reluctant to discuss integration for most of his time in office, even though the city's schools are among the most segregated in the country.

Though the mayor introduced a proposal to integrate eight specialized high schools last year, which requires approval from state lawmakers, some advocates argue the mayor hasn't done enough to address segregation in the vast majority of schools whose enrollment processes he directly controls.

Last week, hundreds of students gathered on the steps of the Education Department's headquarters to demand a more integrated schools system, chanting "Where's our mayor?" The rally was timed for the two-year anniversary of the mayor's convening the diversity task force. De Blasio, who is running for president, did not attend Monday's press conference and has less than three years left in his second, final term.

Tiffani Torres, student integration activist with the group Teens Take Charge and an organizer of last week's rally, said

she was disappointed that the Education Department did not explain in detail how the city hopes to boost integration, especially among the city's high schools.

"The proposals are a step in the right direction, but they don't match the urgency of the crisis of segregation in our schools," said Torres, a student at Manhattan's Pace High School who has pressed the mayor on school segregation.

Some members of the diversity task force understand the impatience for change but are also hopeful more is coming. Lazar Treschan, youth policy expert at the Community Service Society, said accepting the initial recommendations "lay the groundwork" for broader policy changes even if it isn't yet enough.

"This administration will only be successful in integrating schools that dismantle some of the mechanisms that are the greatest barriers to integration — like gifted and talented, middle school screening and high school screening — which aren't in today's announcement," Treschan said.

Members of the advisory group said its second and final report would address academic screening and gifted programs, though they declined to say what changes are under consideration. That report is expected in a few weeks.

The announcement Monday included five new districts that will receive grants to kick off a process of creating district-specific integration policies. They are: Bronx District 9, Districts 13 and 16 in Brooklyn, District 28 in Queens and Staten Island's district 31. Districts in Manhattan and Brooklyn have used that process to change zoning lines or eliminate academic screens.

Many of the 62 recommendations the Education Department accepted with some tweaks address issues such as training teachers in culturally responsive education and requiring schools to work to eliminate racial disparities in suspensions.

Some on the advisory group see such efforts as critical follow-ups to any desegregation plan — to ensure

that "once students from different backgrounds are in a school together that all students are honored and may feel welcome," said Richard Kahlenberg, another member of the committee, and a researcher at the progressive think tank the Century Foundation. But the extent to which the city will be able — or willing — to change student demographics at individual schools is unclear.

The Education Department rejected two of the diversity group's initial recommendations, including hiring a "chief integration officer" and looking into transferring oversight of school safety officers from the Police Department to the Education Department.

Officials said they are "continuing to review" a few other suggestions, such as making more grant money available to districts to spur integration efforts and adding enrichment programs to elementary schools.

## Romeo Santos on upcoming MetLife show: 'It's a blessing'

For Romeo Santos, performing live isn't just about singing a song. It's about giving die-hard fans an entertaining, memorable and life-changing experience.

"When you go to a concert, when you go pay money, it has to go beyond just performing the song — anyone can do that," he said. "It has to be special in many ways."

His commitment to live performance is probably why he's been able to sell out Yankee Stadium twice and is now set to become the first Latin act to perform at MetLife Stadium, home to the New York Giants and New York Jets. The King of Bachata will perform his "UTOPIA the Concert" at the East Rutherford, New Jersey, venue on Sept. 21.

"It is a blessing," the singer of Dominican and Puerto Rican descent, who hails from the Bronx, said in an interview Monday. "I've had loyal fans for quite a while now. To be able to even say that I've already sold out two nights at Yankee Stadium, multiple nights at Madison Square Garden — it's truly a blessing. Now it's a new challenge in my career to do MetLife, so I'm super-excited about that."

At Santos' concerts, the venue usually turns into something like a nightclub as fans show up dressed in their best outfits, with groups of women enjoying a girls' night out or couples dancing closely together on date night.

Santos, 37, said he's never attended a show at MetLife but has been hard at work preparing for the big show. Only a handful of acts have been able to perform a show at MetLife, which can house more than 80,000 fans. They include Taylor Swift, Beyoncé, BTS and the Rolling Stones, who will perform two shows at the venue in August.

"I'm putting more energy into making sure that I show my fans an evolution, production-wise. I want to make sure people leave that stadium saying this is Romeo's best show yet," he said.

Santos, who is the CEO of Roc Nation Latino and has collaborated with Drake and Usher, said he hopes to perform his entire new album, "Utopia," during the show. The album reunites him with his former bandmates in Aventura, the group that gave Santos his start.

"Anything is possible," he said when asked if Aventura would perform at the MetLife show. "I never reveal surprises."

"Utopia" debuted at No. 1 on Billboard's Top Latin albums chart in April and features some of the best old-school bachateros, including Antony "El Mayimbe" Santos, Frank Reyes, Raulín Rodríguez and El Chaval de la Bachata.

Santos said he was successful at keeping the

project a secret.

"I kept telling each and every artist participating, 'If this gets out, I'm not going to be able to use your record.' That really helped," he said. "They understood that this was so important for the culture."



## Artificial intelligence-enhanced journalism offers a glimpse of the future of the knowledge economy

Much as robots have transformed entire swaths of the manufacturing economy, artificial intelligence and automation are now changing information work, letting humans offload cognitive labor to computers. In journalism, for instance, data mining systems alert reporters to potential news stories, while newsbots offer new ways for audiences to explore information. Automated writing systems generate financial, sports and elections coverage.

A common question as these intelligent technologies infiltrate various industries is how work and labor will be affected. In this case, who — or what — will do journalism in this AI-enhanced and automated world, and how will they do it?

The evidence I've assembled in my new book "Automating the New: How Algorithms are Rewriting the Media" suggests that the future of AI-enabled journalism will still have plenty of people around. However, the jobs, roles and tasks of those people will evolve and look a bit different. Human work will be hybridized — blended together with algorithms — to suit AI's capabilities and accommodate its limitations.

### Augmenting, not substituting

Some estimates suggest that current levels of AI technology could automate only about 15 percent of a reporter's job and 9 percent of an editor's job. Humans still have an edge over non-Hollywood AI in several key areas that are essential to journalism, including complex communication, expert thinking, adaptability and creativity.

Reporting, listening, responding and pushing back, negotiating with sources, and then having the creativity to put it together — AI can do none of these indispensable journalistic tasks. It can often augment human work, though, to help people work faster or with improved quality. And it can create new opportunities for deepening news coverage and making it more personalized for an individual reader or viewer.

Newsroom work has always adapted to waves of new technology, including photography, telephones, computers — or even just the copy machine. Journalists will adapt to work with AI, too. As a technology, it is already and will continue to change news work, often complementing but rarely substituting for a trained journalist.

### New work

I've found that, more often than not, AI technologies actually appear to be creating new types of work in journalism.

Take for instance the Associated Press, which in 2017 introduced the use of computer vision AI techniques to label the thousands of news photos it handles every day. The system can tag photos with information about what or who is in an image, its photographic style, and whether an image is depicting graphic violence.

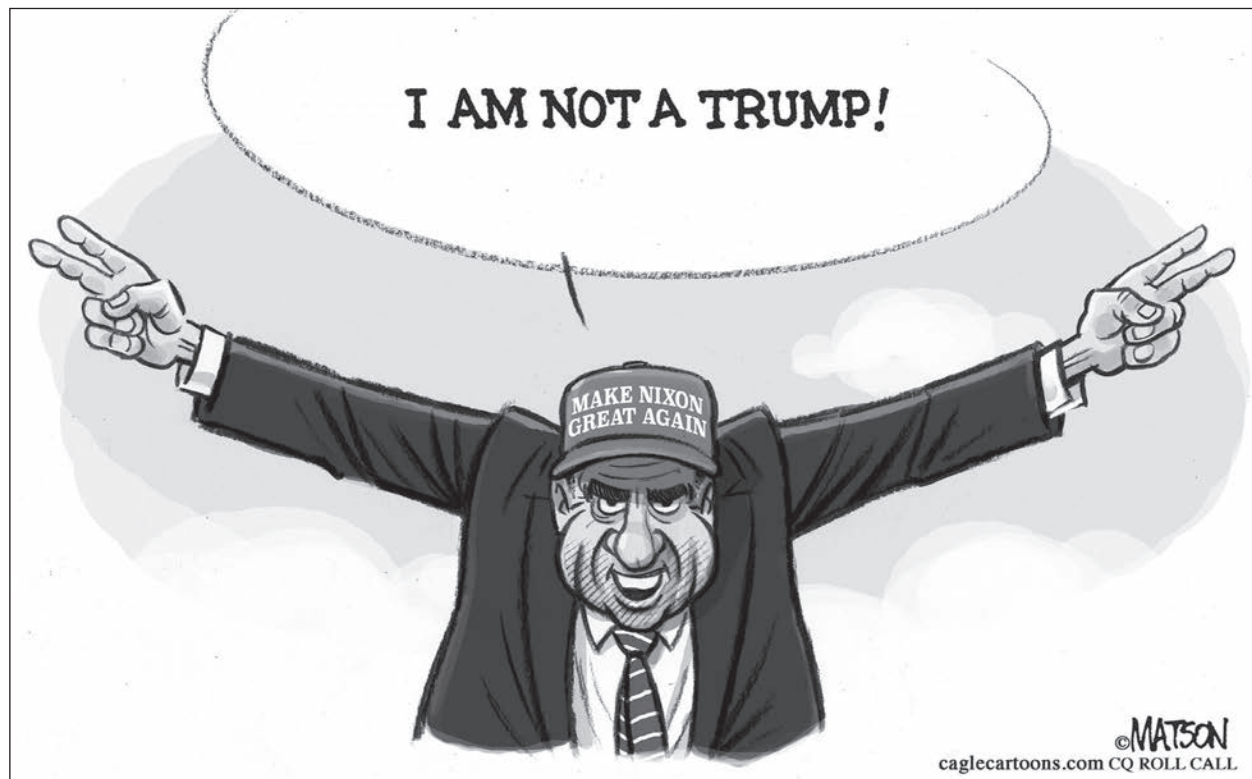
The system gives photo editors more time to think about what they should publish and frees them from spending lots of time just labeling what they have. But developing it took a ton of work, both editorial and technical: Editors had to figure out what to tag and whether the algorithms were up to the task, then develop new test data sets to evaluate performance. When all that was done, they still had to supervise the system, manually approving the suggested tags for each image to ensure high accuracy.

Stuart Myles, the AP executive who oversees the project, told me it took about 36 person-months of work, spread over a couple of years and more than a dozen editorial, technical and administrative staff. About a third of the work, he told me, involved journalistic expertise and judgment that is especially hard to automate. While some of the human supervision may be reduced in the future, he thinks that people will still need to do ongoing editorial work as the system evolves and expands.

### Semi-automated content production

In the United Kingdom, the RADAR project semi-automatically pumps out around 8,000 localized news articles per month. The system relies on a stable of six journalists who find government data sets tabulated by geographic area, identify interesting and newsworthy angles, and then develop those ideas into data-driven templates. The templates encode how to tailor bits of the text to the geographic locations identified in the data

automatically. For instance, a story could talk about aging populations across Britain, and show readers in Luton how their community is changing, with different localized statistics for Bristol. The stories then go out by wire service to local media who choose which to publish.

The approach marries journalists and automation into an effective and productive process. The journalists use their expertise and communication skills to lay out options for storylines the data might follow. They also talk to sources to gather national context and write the template. The automation then acts as a production assistant, adapting the text for different locations.

RADAR journalists use a tool called Arria Studio, which offers a glimpse of what writing automated content looks like in practice. It's really just a more complex interface for word processing. The author writes fragments of text controlled by data-driven if-then-else rules. For instance, in an earthquake report, you might want a different adjective to talk about a quake that is magnitude 8 than one that is magnitude 3. So, you'd have a rule like, IF magnitude > 7 THEN text = "strong earthquake," ELSE IF magnitude < 4 THEN text = "minor earthquake." Tools like Arria also contain linguistic functionality to conjugate verbs or decline nouns automatically, making it easier to work with bits of text that need to change based on data.

Authoring interfaces like Arria allow people to do what they're good at: logically structuring compelling storylines and crafting creative, nonrepetitive text. But they also require some new ways of thinking about writing. For instance, template writers need to approach a story with an understanding of what the available data could say — to imagine how the data could give rise to different angles and stories, and delineate the logic to drive those variations.

Supervision, management or what journalists might call "editing" of automated content systems are also increasingly occupy-

ing people in the newsroom. Maintaining quality and accuracy is of the utmost concern in journalism.

RADAR has developed a three-stage quality assurance process. First, a journalist will read a sample of all of the articles produced. Then another journalist traces claims in the story back to their original data source. As a third check, an editor will go through the logic of the template to try to spot any errors or omissions. It's almost like the work a team of software engineers might do in debugging a script — and it's all work humans must do, to ensure the automation is doing its job accurately.

### Developing human resources

Initiatives like those at the Associated Press and at RADAR demonstrate that AI and automation are far from destroying jobs in journalism. They're creating new work — as well as changing existing jobs. The journalists of tomorrow will need to be trained to design, update, tweak, validate, correct, supervise and generally maintain these systems. Many may need skills for working with data and formal logical thinking to act on that data. Fluency with the basics of computer programming wouldn't hurt either.

As these new jobs evolve, it will be important to ensure they're good jobs — that people don't just become cogs in a much larger machine process. Managers and designers of this new hybrid labor will need to consider the human concerns of autonomy, effectiveness and usability. But I'm optimistic that focusing on the human experience in these systems will allow journalists to flourish, and society to reap the rewards of speed, breadth of coverage and increased quality that AI and automation can offer.

# Promise of marijuana leads scientists on search for evidence

Marijuana has been shown to help ease pain and a few other health problems, yet two-thirds of U.S. states have decided pot should be legal to treat many other conditions with little scientific backing.

At least 1.4 million Americans are using marijuana for their health, according to an Associated Press analysis of states that track medical marijuana patients.

The number of medical marijuana cardholders more than tripled in the last five years as more states jumped on the bandwagon. The analysis is based on data from 26 states and the District of Columbia. The total climbs to 2.6 million patients if California, Washington and Maine are included, the AP estimates.

States that expanded the use of medical pot for common ailments such as severe pain, post-traumatic stress disorder and anxiety saw a boost in enrollment, the AP found.

The U.S. government, meanwhile, both considers marijuana an illegal drug and a therapeutic herb worth more study.

A look at the health claims and research on medical marijuana:

## The evidence

Besides chronic pain, there's strong evidence marijuana or its ingredients can ease nausea and vomiting from chemotherapy and help with symptoms of multiple sclerosis.

Several European countries have approved Sativex, a mouth spray containing THC and CBD, for multiple sclerosis symptoms. Last year, U.S. regulators approved Epidiolex, made from CBD, to treat two rare seizure disorders. THC causes marijuana's mind-altering effect; CBD doesn't get people high.

British drugmaker GW Pharmaceuticals is seeking U.S. approval for Sativex. Other companies are pursuing Food and Drug Administration backing

for products based on marijuana ingredients.

Arizona-based Insys Therapeutics, which filed for bankruptcy protection Monday as it faced fallout over its marketing of an addictive opioid painkiller, is developing CBD drugs for two types of childhood epilepsy and a rare genetic disorder. Pennsylvania-based Zynerva Pharmaceuticals is working on a CBD skin patch for autism and fragile X syndrome, a genetic condition.

Prescription drugs already on the market use synthetic THC to treat weight loss, nausea and vomiting in patients with AIDS or cancer. And researchers continue to study whether marijuana helps with PTSD, back pain and other problems.

## Opioid alternative?

New York, New Jersey, Pennsylvania and New Mexico allow medical marijuana for opioid addiction, despite little evidence it works.

But marijuana may be helpful in reducing use of opioid painkillers. The National Center for Complementary and Integrative Health, better known for its research on herbs and yoga, has set aside \$3 million for studies to determine which of marijuana's 400-plus chemicals help with pain.

THC was excluded, however. Its mood-altering effects and potential for addiction and abuse make it less useful for pain, said Dr. David Shurtleff, the agency's deputy director. And THC has been studied more than the lesser-known compounds.

## Cure for cancer?

Despite online claims, there's only weak evidence that marijuana's ingredients might one day be used to treat cancer. Most studies have been in animals or in the lab. Results have been mixed.

In one study, nine patients with an aggressive form of brain cancer had THC injected into their tumors; any effect on

their survival was unclear. Another study found worrying evidence that marijuana might interfere with some cancer drugs, making them less effective.

## Researching an outlaw medicine

The U.S. government grows marijuana for research at a farm in Mississippi and generally bans grant-funded studies of real-world products.

But a mobile lab inside a white Dodge van allows University of Colorado Boulder researchers to study the potent strains of marijuana many patients consume without running afoul of the law.

Study participants use marijuana in their homes, coming to the van for blood draws and other tests before and after using, said Cinnamon Bidwell, who has federal grants to study marijuana's effects on lower back pain and anxiety.

With increased demand for research pot, the Drug Enforcement Administration created an application process for growers but has not acted on more than two dozen applications.

Such challenges are common for scientists studying an outlaw medicine, said Dr. Igor Grant, who directs the oldest marijuana research center in the U.S. at the University of California, San Diego.

There, scientists are studying marijuana chemicals for children with autism and adults with a brain disorder that causes uncontrollable shaking. Estab-

lished by state law in 2000, the Center for Medicinal Cannabis Research once relied solely on California for funding. The center now has support from private foundations, a sign of growing public acceptance of the research.

## Tracking patients

Minnesota medical marijuana patients must regularly fill out surveys about their symptoms and side effects. That allows researchers to study how people

with cancer react to marijuana.

In one study, a third of cancer patients made only one purchase and didn't come back during a four-month period. They may have died, or decided marijuana was too expensive or didn't work. Of the rest, most reported improvements in vomiting, pain, disturbed sleep, anxiety and depression with few side effects.

Marijuana can ease many symptoms "all at one time," but more study is needed, said study co-author Dr. Dylan Zylla of the

health care system HealthPartners. He has no financial ties to cannabis companies.

Zylla is studying whether cancer patients can decrease their prescription opioid use while using marijuana.

Marijuana "does seem to help patients," he said, "but so much is unknown about the risks, side effects and drug interactions."

## Jon Stewart lashes out at Congress over 9/11 victims fund

Comedian Jon Stewart scolded Congress Tuesday for failing to ensure that a victims' compensation fund set up after the 9/11 attacks never runs out of money.

Stewart, a longtime advocate for 9/11 responders, angrily called out lawmakers for failing to attend a hearing on a bill to ensure the fund can pay benefits for the next 70 years. Pointing to rows of empty seats at a House Judiciary Committee hearing room, Stewart said "sick and dying" first responders and their families came to Washington for the hearing, only to face a nearly deserted dais.

The sparse attendance by lawmakers was "an embarrassment to the country and a stain on this institution," Stewart said, adding that the "disrespect" shown to first responders now suffering from respiratory ailments and other illnesses "is utterly unacceptable."

Lawmakers from both parties said they support the bill and were monitoring the hearing amid other congressional business.

Rep. Mike Johnson, R-La., predicted the bill will pass with overwhelming support and said lawmakers meant no disrespect as they moved in and out of the subcommittee hearing, a common occurrence on Capitol Hill.

Stewart was unconvinced. Pointing to rows of uniformed firefighters and police officers behind him, he said the hearing "should be flipped," so that first responders were on the dais, with members of Congress "down here" in witness chairs answering their questions.

First and foremost, Stewart said, families want to know, "Why this is so damn hard and takes so damn long?"

The collapse of the World Trade Center in September 2001 sent a cloud of thick dust billowing over Lower Manhattan. Fires burned for weeks. Thousands of construction work-

ers, police officers, firefighters and others spent time working in the soot, often without proper respiratory protection.

In the years since, many have seen their health decline, some with respiratory or digestive-system ailments that appeared almost immediately, others with illnesses that developed as they aged, including cancer.

More than 40,000 people have applied to the September 11th Victim Compensation Fund, which covers illnesses potentially related to being at the World Trade Center site, the Pentagon or Shanksville, Pennsylvania, after the attacks. More than \$5 billion in benefits have been awarded out of the \$7.4 billion fund, with about 21,000 claims pending.

Stewart and other speakers lamented the fact that nearly 18 years after the attacks, first responders and their families still have no assurance the fund will not run out of money. The Justice Department said in February that the fund is being depleted and that benefit payments are being cut by up to 70 percent.

"The plain fact is that we are expending the available funds more quickly than assumed, and there are many more claims than anticipated," said Rupa Bhattacharyya, the fund's special master. A total of 835 awards have been reduced as of May 31, she said.

House Judiciary Chairperson Jerrold Nadler, a New York Democrat whose district includes the World Trade Center site, said a 70 percent cut — or any cut — in compensation to victims of 9/11 "is simply intolerable, and Congress must not allow it."

Just as Americans "stood together as a nation in the days following September 11, 2001, and just as we stood together in 2010 and 2015 to authorize and fund these vital programs, we must now join forces one more time to ensure that the heroes of 9/11 are not abandoned when they need us most," Nadler said.

## New York State Bar Association launches effort to save local news

The New York State Bar Association is launching a new effort designed to support and protect local news outlets as the industry continues to shrink.

The association announced Monday that it is creating a task force to study the problem and provide a legal perspective on the challenges facing American journalism.

According to the association, the number

of local news organizations in New York has fallen by 34 percent since 2004.

David McCraw, the deputy general counsel for *The New York Times*, will co-chair the task force. He says local journalism provides a "foundational element" of American democracy and civic culture.

Task force members plan to hold hearings in New York City, Albany and Syracuse. The bar association says the panel is expected to release its findings in 2020.

# Hundreds rally for Layleen Polanco at Manhattan Criminal Courthouse

A low fog hung over the Manhattan Criminal Courthouse as activists, friends and family members gathered to remember the life of Layleen Polanco, a 27-year-old trans woman found dead at Rikers Island last week.

Advocates called on the Department of Correction to fully investigate the circumstances behind Polanco's death.

Polanco's lawyer, David Shanies, speaking at the rally, said that Polanco had known medical issues, including a

history of seizures, and had been placed in solitary confinement while at Rikers — calling into question the nature of her treatment while in detention.

"They treated my sister like she was nothing because of how she decided to be happy," Polanco's sister Melania Brown told the crowd, fighting back tears. "I just want justice for her ... I'm trying to use my pain as my fuel to keep going."

Polanco was arrested for allegedly attempting to bite a cab driver and had been held on \$500 bail. The City has

reported.

In April of this year, New York City passed a sweeping bail reform bill that will go into effect in January 2020. "Had that law been in effect, she wouldn't have been [at Rikers]," Shanies said.

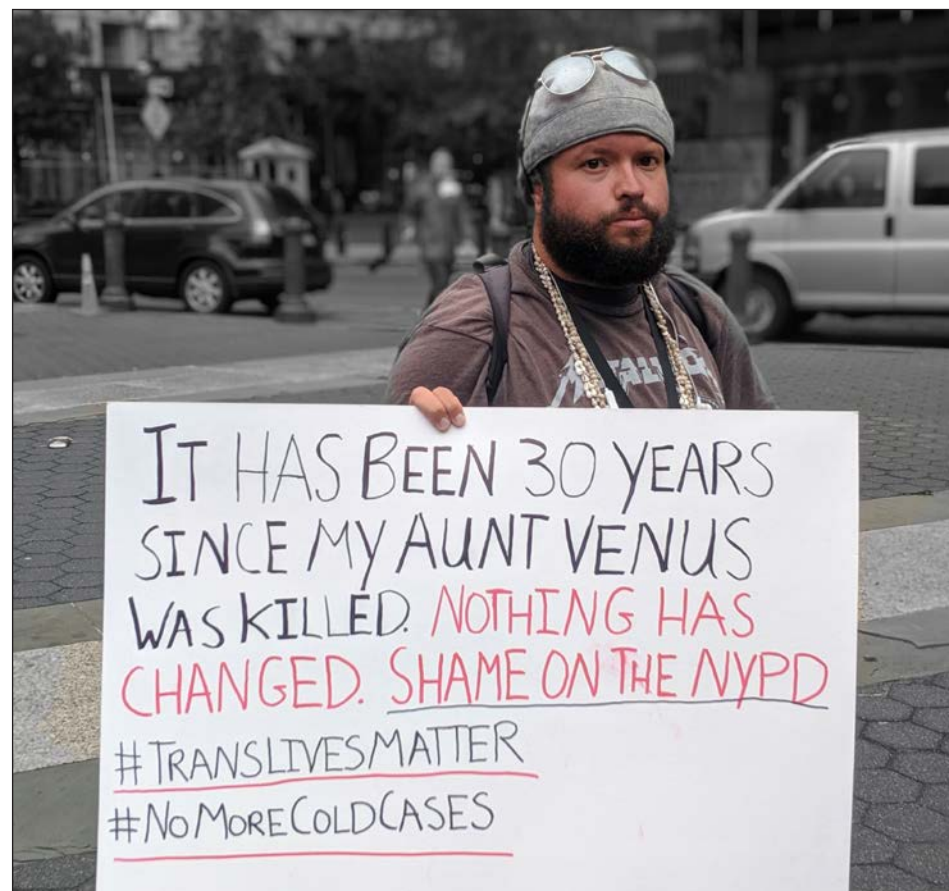
A number of activists and members of the House of Xtravaganza, a ballroom subculture popular among members of the LGBTQI+ community, spoke at the rally to demand justice for Polanco.

## Councilmembers introduce 'renewable Rikers' bills

Astoria Councilmember Costa Constantinides introduced a "renewable Rikers" legislative package on Monday that would begin to transform the infamous island into a literal renewable energy powerhouse.

"For generations, Rikers Island has been a place of despair for many New Yorkers caught up in a fractured criminal justice system," said Constantinides, chair of the Council's Committee on Environmental Protection. "These bills are a downpayment for a brighter future for this island — one that actually serves New York communities instead of tearing them apart."

Constantinides' district includes Rikers Island, which is set to close its jails by 2027 as part of a plan to open

a new jail in each borough but Staten Island.

The three-bill package would move control over the island from the New York City Department of Correction to the New York City Department of Environmental Protection, and have the city measure the island's renewable energy capacity and how much wastewater could be diverted to the island. Wastewater treatment on the island could potentially eliminate several aging treatment facilities in northern Queens, the South Bronx and Upper Manhattan, which would free up hundreds of acres of public land, according to a statement released by Constantinides' office.

The bill comes after Constantinides hosted a panel about the renewable Rikers issue on June 6. There, Constantinides, as well as

other Queens politicians like U.S. Rep. Alexandria Ocasio-Cortez, spoke about "environmental racism," or how the city's lower-income neighborhoods and communities that are predominantly made up of people of color, who can be more exposed to pollution because of their proximity to facilities like airports, power plants or wastewater treatment plants.

"It's time for us to think how we can get climate justice for the same communities that were torn apart by the criminal justice system, emblematic in Rikers Island," Constantinides said at the panel, as previously reported by the *Eagle*.

The package, which is co-sponsored by Manhattan Councilmember Helen Rosenthal, will be presented to the City Council on Thursday.

# Advocates submit 26K petitions demanding 'Justice for Chanel'

Dozens of criminal justice reform advocates joined the family of the man convicted of killing Howard Beach resident Karina Vetrano to call on the Queens' District Attorney's Office to reopen the controversial murder investigation Tuesday.

Chanel Lewis, 22, was convicted for first-degree murder at retrial and sentenced to life in prison without the possibility for parole in April. Days before the jury reached its verdict, an anonymous letter from a person claiming to be an NYPD officer detailed potential racial bias from the

early days of the investigation into the August 2016 murder.

The account, first published by the *Daily News*, galvanized justice reform advocates and prompted activist Mo Glover to start an online petition demanding that the DA's office investigate the claims.

The petition accumulated 26,000 signatures, which advocates from Vocal-NY and the Color of Change delivered to top DA officials at Queens Borough Hall Tuesday.

"I'm not a politician ... I'm just a woman of color and native New Yorker who heard about Chanel Lewis' case and became very alarmed," Glover said. "I hope more New York-

ers become more involved in the criminal justice system."

A Queens Supreme Court jury determined April 1 that Lewis encountered Vetrano while she jogged in a park near her home and attacked her, strangling her to death and sexually abusing her. The seemingly random act generated international attention and led to a massive manhunt in Howard Beach and surrounding, predominantly black, neighborhoods of Brooklyn.

NYPD officers obtained DNA samples from black residents of the area in what critics have called a "race-biased dragnet."

# Central Park Five emerges as issue in Queens DA race

Thirty years after five black and Latino teenagers were wrongfully convicted of a brutal rape in Central Park, the high-profile case, marked by biased media coverage and alleged misconduct by prosecutors, has once again emerged as the subject of intense public scrutiny.

In the past two weeks, the case of the Central Park Five has been the focus of the new Netflix series "When They See Us," the catalyst for campus protests and an issue in the race for Queens District Attorney ahead of the June 25 primary.

One Queens DA candidate, public defender Tiffany Cabán, participated in a demonstration calling for the Manhattan DA to open an independent investigation into the wrongful conviction of the five teens on Tuesday morning. Another candidate, former Judge Gregory Lasak, received money from Linda Fairstein, the lead assistant district attorney on the case, who has faced significant criticism for pursuing convictions despite inconsistent confessions and a lack of forensic evidence linking the boys to the scene. Lasak has received a significant amount of money from for-

mer prosecutors.

Lasak's Campaign Chairman Bill Driscoll said Lasak donated the money from Fairstein to the Innocence Project.

"This powerful film shined a bright light on who's responsible for the tragic miscarriage of justice in the Central Park 5 case," Driscoll said. "As the only candidate who won freedom for nearly 2 dozen wrongly-convicted people of color, Greg Lasak takes this issue very personally and promptly donated the contribution to The Innocence Project, with which Lasak has worked closely."

Fairstein, who prosecuted the teenagers for the crime, donated \$250 to Lasak's campaign on April 30, according to Board of Elections campaign finance records. She made the donation a month before the premiere of "When They See Us" prompted reexamination and reignited outrage over the 1989 case — in particular, Fairstein's pursuit of a conviction.

In 2002, a convicted rapist came forward to reveal that he had committed the attack in Central Park, and DNA at the scene matched his. The Central Park Five — Antron McCray, Kevin Richardson,

Yusef Salaam, Raymond Santana Jr. and Kharey Wise — had their convictions overturned that year.

The city settled a lawsuit with the five men for \$41 million in 2014. But to a public increasingly aware of bias in the criminal justice system, the case was far from closed.

Earlier this month, student protests and online petitions at Vassar College led to Fairstein resigning from her position on the school's Board of Trustees, the *Brooklyn Eagle* reported. Fairstein, a best-selling author, also stepped down from the board at Safe Horizon and the Joyful Heart Foundation, which serves survivors of sexual violence, *The New York Times* reported.

"The boys she wrongfully helped imprison are our neighbors, brothers, sons. They are now men that have been robbed of a life," wrote Vassar student Mari Robles, who drafted the petition. "I have been taught to fight against injustice by my amazing professors and classmates. I call on Vassar alums and current students to demand that she be taken off the board of trustees."

Top leaders in city government, justice reform advocates and Queens DA

hopefuls are championing a similar message.

Cabán joined Public Advocate Jumaane Williams, activist Akeem Browder and other criminal justice reform advocates Tuesday morning at Foley Square to "demand an independent investigation into the cases of those involved in the prosecution" of the Central Park Five, according to a press release ahead of the event.

An investigation by the Manhattan DA's Office

would hold the prosecutors "accountable for the wrongdoing they committed while working on the case" and potentially highlight "other cases of injustice that occurred during their tenure," the press release said.

"It is clear that former Assistant District Attorney Linda Fairstein, prosecutor in Central Park Five case, engaged in immoral, unethical, and illegal conduct — taking advantage of vulnerable, young, Black and

Latino youth by orchestrating false confessions from the teenagers," the press release continues. "Fairstein's actions were not only unjust, but possibly criminal, which many believe could be reason for disbarment."

Councilmember Rory Lancman, another Queens DA candidate, has also chaired hearings of the Council's Committee on the Justice that featured the Central Park Five discussing wrongful conviction.

# State Senate considers new slate of LGBTQIA+ rights bills

With Pride Month in full swing, a group of New York state senators detailed a package of LGBTQIA+ rights legislation Tuesday that would notably lift the ban on gestational surrogacy in New York — one of just two states in the nation where the practice is illegal.

The bills would also abolish the “gay panic” defense, create a LGBTQIA+ suicide prevention task force and restore LGBTQIA+ veterans’ eligibility for state programs if they were less than honorably discharged because of their sexual orientation or gender expression.

“We are standing here at a historic moment in New York,” New York State Senate Majority Leader Andrea Stewart-Cousins said during a press conference about the bills.

The repeal of the gestational surrogacy ban — which prohibits gay or infertile cou-

ples from paying a woman to carry and deliver their baby via fertilization,— is championed by State Sen. Brad Hoylman, who has two children born through surrogacy.

If a gay or infertile couple currently wants to have a child through a surrogate, they have to leave the state and seek a surrogate somewhere else. The new bill would ensure that parents would be secure in their legal rights to their children delivered via surrogate, and that the surrogates would receive legal counsel and health insurance provided by the new parents.

“Now that we have marriage we can build the baby carriage,” Hoylman said.

With the passage of the bill, Hoylman said, New York surrogates would have the strongest protections of any state in the country.

“Watch What Happens Live” host Andy Cohen, another advocate for the bill, and spoke at the press conference about how he had to

travel to California to find a surrogate to have his son. He said he was “shocked and amazed and crestfallen” to find out that surrogacy was not allowed in New York.

The elimination of the “gay panic” defense, another bill under consideration, would abolish the legal defense of excusing a violent attack or homicide on the grounds that the attacker was under extreme emotional duress after an LGBTQIA+ person revealed their identity.

Gov. Andrew Cuomo signaled that he would be open to signing the surrogacy bill and the “gay panic” elimination bill if they landed on his desk.

These are not the first bill addresses LGBTQIA+ rights in New York this year.

In January, state lawmakers passed GENDA, which made it illegal in the state to discriminate based on gender identity or expression, and banned gay conversion therapy.

## Recent forum on diversity in specialized high schools favors ‘objective’ admissions exam

A Friday night forum on diversity in schools and the fate of the Specialized High School Admissions Test made clear how a bulk of southern Brooklyn parents and educators feel about the mayor’s proposal to eliminate the exam.

The event, hosted by State Sens. Andrew Gounardes, John Liu and Robert Jackson, packed the I.S. 201 auditorium in Dyker Heights where, for two hours at the start of the weekend, parents, educators and even kids testified primarily in favor of the test.

The SHSAT is currently administered to eighth- and ninth-grade students in order to determine admission to all but one of the city’s specialized high schools. Of the nine elite high schools in the New York City public schools system, eight use the SHSAT as the sole criteria for admission.

The mayor and Schools Chancellor Richard Carranza are pushing to eliminate the SHSAT in hopes of upping racial diversity in the top high schools like Brooklyn Technical High School and Peter Stuyvesant High School, which currently enroll low numbers of black and Latino students.

The incoming freshman class at Stuyvesant High School, for example, has only seven black students, accord-

ing to Chalkbeat. Yet, black and Latino students make up 68 percent of the overall population in New York City schools, according to the Mayor’s Office.

Under de Blasio’s plan, the SHSAT would be replaced by a new enrollment system that would allow the top seven percent of students in each of the city’s middle schools to gain admission to specialized high schools.

But Asian-American parents, whose children make up a large percentage of the student population in specialized high schools (more than 60 percent), and who made up a large part of Friday night’s attendees, have said they see the administration’s plan as an attack on kids who work hard to ace the SHSAT.

“No student in the city is denied the freedom to work hard and get into a better school,” said the first speaker up, Leong Cho, who maintained that, while diversity is important, eliminating the SHSAT, which they called a “completely objective” gauge, isn’t the solution.

“And no parent is also denied [the freedom] to spend more time or resources to help his or her kids get into a better school.”

Nearly all subsequent speakers echoed Cho’s concerns, including Community Education Council 20 President Adele Doyle and Christa McAuliffe Middle School

Parent Teacher Organization President Vito LaBella, who equated the disparity in specialized high school to a lack of preparedness throughout the city.

Instead, both called for the focus to be shifted on the Gifted and Talented Program. (There are currently bills being heard in both the Senate and Assembly committees that would require the New York City Department of Education to create more gifted and talented programs and classes.)

Referencing his past experience with the NYPD, LaBella told audience members, “When the Guardian Angels wanted to patrol the subways for free, they were told by the city and the unions that they couldn’t do it, because the city and the police unions wanted to put politics over the safety of their officers and politics over the safety of the public.”

“Fast forward 40 years and what’s changed?” he went on. “The DOE is now putting politics above children.”

The SHSAT encourages a “work ethic to which every student in the city should aspire,” according to Doyle. “To say that our public school system is good enough is to deny the fact that only 37 percent of our public high school students [are] deemed college-ready compared to the 100 percent of students who graduate from special-

ized high schools.”

This was the second southern Brooklyn forum on the topic. It came on the heels of a June 1 meeting with parents and Assemblymember William Colton — who was at I.S. 201 on Friday, and who taught in the public school system for 11 years before entering politics — to brainstorm ways to keep the SHSAT in place.

“The test is objective. You can’t get into Brooklyn Tech because you know somebody,” he has said.

Gounardes told the *Brooklyn Eagle* in a statement that he is committed to hearing residents out on the issue. “The quality of a child’s ed-

ucation is of profound importance to any family, and every family deserves the best — beyond the relatively narrow scope of specialized schools,” he said.

“Simply eliminating the SHSAT would disproportionately target first- and second-generation immigrant families. Instead, we need a comprehensive approach to ensure diversity in public schools and address the fundamental disparities in our education system. Free public education from pre-k through college would be a big step in the right direction.”

Despite what appears to be constant pushback to the mayor’s plan, a Quinnipiac

poll released earlier this year showed broad support for overhauling the admissions process. In it, 63 percent of New York City voters said they favored admissions changes to boost diversity, with 57 percent on board with scraping the entrance exam entirely.

“The admissions process to New York City’s top high schools has become a lightning rod. And New Yorkers say rethink it. They favor considering other factors besides a standardized test as the only door to entry,” said polling analyst Mary Snow.

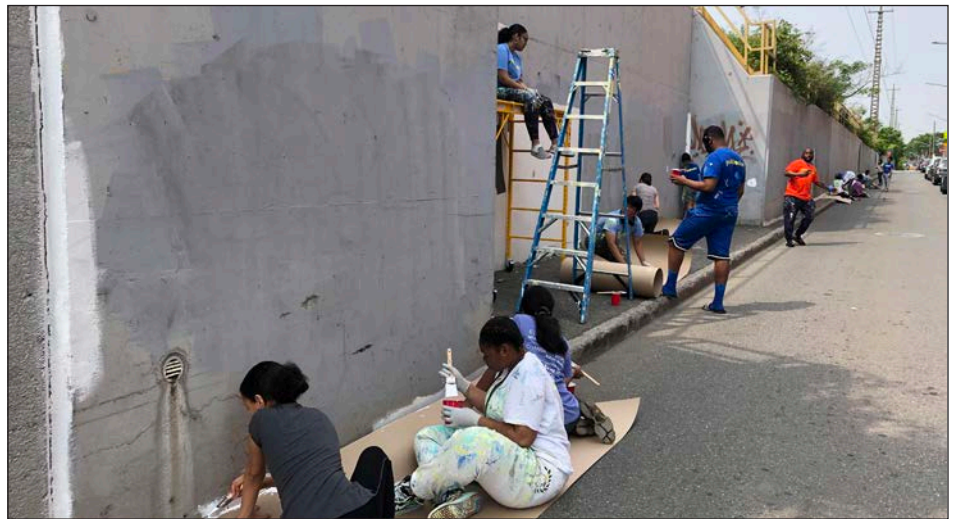

## Corona kids beautify barren walls with help from nonprofit

Gray and graffitied walls once sat across from the Corona Academy of Arts and Sciences — that is, until the Publicolor Paint Club got to them.

Publicolor is a nonprofit youth development program with a goal of using art and design to engage struggling low-income students in their education. ## Decision pending on prosecutors' request to disqualify defense in NYPD murder case

A Queens Supreme Court judge said a few issues need to be resolved before he makes a decision on an unusual request from Queens prosecutors, who asked that he disqualify defense counsel in the case of a man accused of murder in the death of an NYPD officer.

The Queens District Attorney's Office argued in April that disqualifying the Legal Aid Society defense team is in the best interest of defendant Christopher Ransom, who is charged with felony murder for his alleged role in the February shooting death of NYPD Detective Brian Simonsen at a Richmond Hill cellphone store.

Prosecutors said that another Legal Aid attorney represented Elijah Hanley, a man who allegedly purchased a phone that Ransom stole in another robbery. Prosecutors may call Hanley as a witness, which would create a conflict of counsel, they wrote in their motion to the court.

Ransom's attorneys filed a response stating that their Legal Aid colleague no longer represents Hanley, and that Ransom chose to retain them as counsel even after learning of their earlier representation.

Queens Supreme Court Justice Kenneth Holder said he would not issue a decision until other issues are resolved, including whether Hanley and Ransom are fully aware of the circumstances.

"The point is, that if Mr. Hanley took the stand at Mr. Ransom's trial your agency would have to go all in against Mr. Hanley and do everything possible to render any testimony he proffers as unreliable," Holder said.

"And the extent to which that is done or not done should concern your client since he is entitled to the effective representation of counsel," he continued.

Holder scheduled a new hearing for June 26.

In their motion, prosecutors state that "two lawyers from the same law firm simultaneously representing two clients

whose interests actually conflict cannot give either client loyalty," the motion states.

Legal Aid said there is no conflict and questioned why the DA's Office did not disclose the information about the representation issue until mid-April, nearly two months after prosecutors first learned about the connection between Ransom and Hanley.

"We are very concerned that the Queens District Attorney's Office would seek to deny our client his Constitutional right to counsel of his choice," said Jamal Johnson, attorney-in-charge of Legal Aid's Homicide Defense Task Force last month. "We are further concerned that the Office withheld key information about the identity of one of their witnesses in what appears to be a transparent effort to manufacture a conflict for strategic advantage. The Legal Aid Society's Homicide Defense Task Force — a team which includes several attorneys, mitigation specialists, investigators, forensic

and digital units, and other resources — has represented Mr. Ransom since the inception of this case and we have the necessary resources to provide him the robust defense that he is entitled to."

## Woodhaven man convicted for stashing porn videos of kids as young as 2 years old

A Woodhaven man who maintained a collection of child pornography that featured kids as young as 2 years old engaging in sexually explicit acts and poses was convicted on more than 65 counts Monday.

The graphic content on Diego Guerra's computer and other electronic devices included a 24-minute video of a teenage boy performing a sexual act on a girl whom authorities believed was between the ages of 6 and 8 years old. Acting Queens District Attorney John Ryan described the content as "vile" in a statement.

"These horrifying crimes should serve as [a] reminder to all that the internet must be policed in order to prevent further instances of children being violated and degraded in the worst imaginable ways," Ryan added. "The defendant deserves to be adequately sentenced for his role in this despicable crime."

Guerra was convicted after a two-week-long jury trial pre-

sided over by Justice Michael Aloise. At sentencing on July 30, Guerra faces up to seven years in prison.

Investigators first linked Guerra to the content on Jan. 5, 2017 through his IP address. Child pornography images were uploaded to ARES, a peer-to-peer file sharing network, and detectives determined that Guerra shared multiple videos of children between the ages of 6 and 12 engaging in explicit sexual acts with other underage children and several adult males.

The 24-minute video was discovered by investigators on Jan. 19, 2017. Investigators executed a search warrant at Guerra's home on July 27, 2017 and, once inside, encountered Guerra, who admitted to owning a laptop and several other electronic devices retrieved from the home.

A forensic exam performed on the laptop recovered 60 additional images of children between the ages of 2 and 12 with their genitals exposed and engaging in lewd sexual acts.

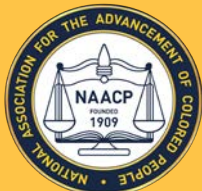
